Hiawatha Parks and Recreation Regular Meeting August 14, 2018

Dan Wilkes called the meeting to order at 6:17p.m. in the Hiawatha Council Chambers. Present: Deb Theis, Dawn Ewoldt, Dan Wilkes, Brandon Lynch Absent: Michelle McIllece Employees: Kelly Willadsen, Parks and Recreation Director, Ambyr Severson, Administrative Coordinator, Kim Downs, City Administrator and Aime Wichtendahl, City Council Member. Guests: Dan Hoffman

Motion by Deb Theis, second by Dawn Ewoldt to approve the August 14, 2018 agenda as amended. Motion carried. Motion by Brandon Lynch, second by Deb Theis to approve the minutes of June 12, 2018. Motion carried.

Professional Services Agreement through MSA- Kelly Willadsen, Director of Parks and Recreation stated that with the recent purchase of 18 acres for new park development in the NW territory, we are ready for the planning stages to see if our visions align with our community's needs. In doing so this will require a concept plan through a professional planning service. The concept will include analysis of our planning thus far along with our goals and objectives, evaluating our existing site, public engagement through focus groups and putting preliminary cost estimates together for proper development.

Along with developing a concept plan, we would like to update our Comprehensive Park plan at the same time. By doing these two projects together we will be able to collect data that will guide us on the right path for the next 10 years. Right now, our Comprehensive Park plan is reaching its final years (2010-2020) and has out grown its data. Much of it does not pertain to the direction we are heading, or has not been completed based on the direction of you, as commission members and the City Council. With a dog park, Hodge Property, and an 18-acre park it will be a great opportunity to update where we are at and the future moving forward in Parks and Recreation.

With many residents' sharing their opinions on Hodge Property as well as what the 18-acre park will looks like, we want to make sure we are steering in the right direction. Based on the Citizen survey that was completed in 2016 there are suggestions to look at trail connectivity, development of a civic recreation center from our 2018 strategic plan, recreation programs for all ages, along with more ADA features at our playgrounds and park facilities. To gain more understanding from our residents we will be putting together focus groups to help guide us in the process.

Both of these projects together will take nearly 6 months to complete. It will be a great opportunity for the commission to get involved in the development of the future park, along with the existing features our City currently has and the direction we would like to take over the next ten years. MSA will have 3 to 4 meetings with our Commission to collect feedback and generate ideas and suggestions for our plan.

MSA has been very involved in other city projects in the last few years and has a great deal of information about our City from the recent City Master Plan and other engineering projects. Because these two projects go hand in hand, we can save cost by combining the two projects into one contract and working with a company that has quality work and specialization in park planning.

By having funding left from the sale of the 18 acres, this will allow us to complete the contracted work. Below you will see what is covered, and the process we will go through over the next six months. The

total for the two projects comes out to \$21,900 a cost savings of \$6,300 by combining the two projects.

<u>Northwest Park Concept</u>- This project will take approximately four months to complete. The project includes four phases, three Park and Rec Commission Meetings, one City Council Meeting, and one Public Workshop (focus group). Below is the estimated timeline for the project.

Guthridge Trail Reconstruction-

When Guthridge Park Trail was first constructed, it was created out of lime rock chips. In 2004, with the preparation of RAGBRAI coming through and the timeliness, pavement was installed over the lime subbase instead of having an accurate rock base. By doing this, approximately 500ft of the trail now has excessive cracking and deterioration. This can be easily seen over by the tennis courts and in the middle section of the park between the playground and the bandshell. There is also, 400ft of the trail does not meet ADA requirements for cross slope (more than 5% cross slope) making it difficult for trail users and wheelchairs to maneuver. Based on ADA guidelines, 1.5% cross slope is recommended, but cross slopes should be a minimum of 1% and shall not exceed 5%. Guthridge trail is at 5.5% and higher in certain areas.

Because of the poor subbase on the south end of the trail it is not a candidate for an overlay. Patching is also eliminated because of the difficulty of getting equipment in and out without damaging other portions of the trail.

After further evaluation with public works and city engineering we are looking to replace all the asphalt trail from the middle cross trail to the south (the north end of the trail was constructed later and was installed correctly meaning no updates needed). I've inserted a map below that shows an aerial highlighted in yellow. We believe it will be best to replace the south end trail with new sub-base and asphalt. We would need to excavate a 10' wide path and put 8' of 3" asphalt trail in.

Below you will see three quotes from LL Pelling, Pate Asphalt and Kluesner Construction. Pate Asphalt came in the lowest at \$50,330.00 with Kluesner and LL Pelling to follow. You

will notice a slight gap in the quotes; after further review by the city engineer they all align with the proper scope. Pate is a responsive and responsible bidder, we have worked with them on past projects and know they do quality work. We would like to complete this project in the fall based on weather and scheduling. Because of ADA requirements and safety for our trail users, we believe this is a vital project for completion.

In the 2018 CIP we originally budgeted \$5,000.00 as we thought overlay and patching were an option at the time. Today, due to the inability to patch/overlay sections and the lack of meeting ADA requirements we now need \$50,330.00. With \$250,000.00 funds leftover from the purchase of the Taylor property, it will allow us to complete this project, yet still have funding available to put towards the NW park planning. I would like your approval to move forward with the necessary Guthridge park trail updates, and to make a recommendation at the September 19th, 2018 Council meeting.

Moving forward we will be reviewing all park trails, so we have proper dollars set aside in the CIP.







Analysis of South portion of Guthridge Park trail. Facts:

- 1. Trail is 1600 ft long x 8 ft wide.
- 2. Trail is 14 years old and was installed on lime rock chips subbase because we wanted it done for 2004 RAGBRAI.
- 3. Approx. 500 ft of the trail is in need of replacement because of excessive cracking and deteriorated surface.
- 4. Approx. 400 Ft of the trail does not meet ADA requirements for cross slope (more than 5% cross slope).
- 5. Trail is not a candidate for an overlay because of poor subbase.
- 6. Patching is not recommended because of difficulty of getting equipment in and out without damaging other portions of the trail.
- 7. Public works and city engineer's recommendation is to replace all of the south portion of the trail.

Parks:

Dog Park- Plans Advance for Hiawatha Dog Park

Linn County and the City of Hiawatha are progressing on plans for Hiawatha's first dog park. The proposed park will be located south of Boyson Road and just east of the Cedar Valley Nature Trail in Hiawatha.

On August 20, 2018, the Linn County Board of Supervisors approved leasing .72 acres of county-owned land to Hiawatha as part of the planned dog park that, once complete, will be just under 2 acres. This is the first step in getting the land ready for a future dog park. Other work includes working with Linn County Conservation on a design that incorporates existing trees and creating green space for open grassy areas. Additional parking is also planned. Linn County Conservation owns the approximately 1.48 acres directly south of the planned park. This area is a high-quality urban forest that currently is not part of the planned park area.

A completion date could take over a year with an estimated construction cost of \$100,260. In meeting the growing needs of our community, a partnership was formed between the City of Hiawatha and Dave Wright for the build out of the dog park. Between Dave Wright and volunteers, the estimated construction cost will be minimalized for the city of Hiawatha with annual maintenance cost of the park below \$2,000.

"The future Hiawatha dog park initiative is regionalism working at its best. It is inspirational to see government entities and the public working together for a common goal," Hiawatha City Administrator, Kim Downs said.

"We are pleased Linn County is able to help the City of Hiawatha advance its plans for a dog park and add to the quality of life amenities available in Linn County. We anticipate this will be a popular destination for area residents and their canine companions," John Harris, chair of the Linn County Board of Supervisors said.
