Hiawatha Economic Development Corporation (HEDCO), Brent Cobb opened the "State of the City" sharing Hiawatha's story of continued growth and expansion both commercially and residentially. Cobb introduced Mayor Theis who spoke of the City's progress with the Tower Terrace Interchange. The City continues to move forward addressing the Federal Highway Commission in Washington, D.C. concerns little by little, with plans to update our local Department of Transportation (DOT) this fall of our progress small. Theis

points out the City is farther along than ever before even with the DOT's new issues. Theis stated, "We will keep forging ahead because we know this interchange is the key to our economic development future for all our metro communities. Mayor Corbett has said that it took 25 years to get Highway 100 approved. I hope it doesn't take that long for the Tower Terrace Interchange approval."

The current North Center Point Road Project is almost complete with most of the detail items finished to the north. The City Council is excited to move forward with the final improvement to the street which is the Emmons Street/Center Point Road/Robins Road intersection. Property acquisitions have begun and Theis is happy to announce that the Barber shop and the Coin shop will be relocating in new quarters within the City. The City Council has tried to keep the disruption of business activity to a minimum. The plan is to purchase the properties that are necessary to redo the intersection and remove them as soon as possible to begin the necessary utility work. Actual road construction should begin in early 2016.

Theis gladly speaks of the private redevelopment of property between North Center Point Road and Robins Road. A number of older buildings have been removed and today a beautiful new office building is almost complete. This is the corporate offices for Hawkeye Communication and Hand in Hand Early Care and Education Center. This kind of redevelopment is exactly what the Mayor and Council had hoped would happen as Center Point Road improved. With the reconstructed intersection, the City hopes to see more of this kind of redevelopment.

Theis was proud to talk about the public/private partnership promoting development commercially and residentially with the new Dave Wright



Nissan/Subaru Dealership along North Center Point Road/Boyson Road, new business pods/warehouse growth along Tower Terrace/Stamy Road within the Tower Commerce Center and along Robins Road and residential developments along Loggerhead Road - Pines at Turtle Creek and Rolling Prairies. In time these developments will support a sound economy for the City.

Mayor Theis took a few minutes to recognize five of the top 25 fastest growing businesses located right here in Hiawatha as reported in the Corridor Business Journal: Midwest Microwave Solutions, Inc., Premier Staffing Inc., Ahmann Properties, Compass Commercial Services and Ready Wireless LLC. Mayor Theis also acknowledged City staff. He stated, "These individuals are the people who help keep our City moving forward."

The State of the City ended with Keynote Speaker, Iowa Department of Economic Development Director Debi Durham. She is no stranger to economic development. She works diligently with the Governor and our legislators to restructure the department to create a public/private partnership to update and improve lowa's delivery of our economic development services. Debi shared lowa successes and how lowa is going to continue to grow and thrive in this economy by measuring its production of services and by providing incentives with lowa's strong entrepreneurs.

I-380 Cleanup with Rapids Reproductions

Potential donors must be at least 17 years of age (16 with parental permission form available through www. bloodcenter.org) and weigh more than 110 pounds. A photo I.D. or MVRBC Donor Card is required to donate. Donors who last gave blood on or before 6/16/14 are eligible to give at this drive.

Blood donation is a safe, simple procedure that takes about 45 minutes to one hour. Individuals with diabetes or controlled high blood pressure may be accepted as eligible donors.

The Mississippi Valley Regional Blood Center is the provider of blood and blood components to more than 87 hospitals in Illinois, Iowa, Missouri and Wisconsin.

Hiawatha Protects Wetland to Reduce Flooding

As part of our National Pollutant Discharge Elimination System MS4 program, the City of Hiawatha oversees erosion control on construction sites, the design and installation of storm water management plans, and maintenance of the City's overall storm water drainage system. The system includes erosion control measures, detention devices, retention basins, and wetlands. All of these components help to control storm water runoff thus reducing erosion and preventing runoff and pollutants from reaching our lowa streams, rivers, and lakes.

One of our largest wetlands is located northwest of Alwine Court and Ashworth Court and north of Willowwood Drive. In the past the creek bed filled with silt and debris due to construction and drainage flow in the area. In 2010 citizens living next to the creek asked the City to dredge the original stream that ran through the wetland to reduce the water that was coming into their yards during heavy rains.

In 2011, after researching the benefits of wetlands, the City hired an engineer who drew up a plan to dredge the original stream using guidelines provided

by the Corp of Engineers. The City spent approximately \$250,000 to have a contractor dredge the original stream and channel the water into the middle of the wetland. The original top soil was replaced and new wetland plants were installed. In 2013 the City put up signs designating the area as an environmentally sensitive area and asking people to keep out of this area.

Wetlands act as natural retention basins. The plants slow the flow of water from the area and protect properties and reduce possible downstream flooding. The plants in the wetland reduce soil erosion by holding the soil in place. Finally, the wetland provides habitat and food for animals such as deer, fowl, fox, turkey, and other wildlife.

The City asks that people help protect our wetlands by not mowing the area, by not cutting or planting trees in the area, and by not making trails in the area because this leads to erosion. The City appreciates the help of the wetland neighbors and the citizens of Hiawatha in preserving our City's natural habitats and its natural resources for the benefit of all future generations.

Fire Inspections

The mission of the Hiawatha Volunteer Fire Department is to enhance our community by providing services and programs to protect lives, property, and the environment. We will accomplish this by being pro-active by providing fire and life safety education and fire prevention programs to reduce the incidence of injury and fire, and by providing emergency response services to reduce losses in life and fire when an event occurs. A fire can have a devastating effect on a community. We protect the community by preventing the loss of life or property... simply said, we want a safe community. One of the ways we do this is by conducting fire inspections. Our primary focus when performing these inspections is life safety-preventing injuries or death. After that we want to prevent loss of property to fire. While our focus isn't on "enforcing the code", we do follow the 2009 International Fire Code that is used similarly throughout the area. The City "adopts" the code and makes minor changes that fit Hiawatha in Chapter 160 of the Code of Ordinances.

Recently the Fire Department began using an important tool. As our goal is a fire and life safe environment, we now provide a "Fire Safety Checklist" to businesses prior to a scheduled inspection. This list provides an overview of items that will be reviewed during an inspection. Businesses can then prepare for the inspection ahead of time, at their own pace, improving safety and compliance. This improves the efficiency of the inspection process and provides a year round reference for businesses to refer back to. Please remember, our intent is always to protect life and property, through prevention, education, and response. Area Firefighters Train Together

On Sunday June 29, 2014 several fire departments participated in a house burn and tanker drill. This house burn, coordinated by the Monroe Township Fire Department, was at a vacated house on Toddville Road about one mile west of Toddville. The house was set on fire numerous times and then extinguished by crews for training purposes. A key component of this particular drill was a "tanker drill". Many areas outside of the City limits do not have fire hydrants, so fire departments work together to deliver water during the fire. Fire Departments from Hiawatha and Monroe Township, along with Robins, Palo, Walker, Alburnett, and Springville participated in the drill.

Fire Departments don't often work together, except during emergencies. Fighting the fires, and hauling water in realistic circumstances, such as in this drill, allow the departments to learn about the equipment each agency has and determine what obstacles to working together exist. In this case, coordinating a large number of water tankers, delivering to the same location, from multiple fill sites, was a challenge, and the departments learned from it.

Even though the City of Hiawatha has fire hydrants, there are a few areas protected by Hiawatha Fire Department that don't. This kind of training also serves as a backup in town, should the water system be impaired and water must be hauled to a fire.

Firefighters to Collect for MDA

Members of the Hiawatha Fire Department along with the Muscular Dystrophy Association, will kick off the fire fighters' annual Fill the Boot fundraising campaign to benefit children and adults affected by muscle disease throughout Hiawatha.

Members of the Hiawatha Fire Department will fan out around Hiawatha with boots in hand for this year's drive. Watch for the Firefighters at intersections around Hiawatha starting the weekend of August 22, and at other events and locations in the weeks leading up to Labor day.

"Throughout 2014 MDA and fire fighters are celebrating 60 years of proud partnership, joined together in the fight against life-threatening muscle disease", said MDA Representative Jillian Sharp. "Fire fighters in the Hiawatha area do more for MDA and the families we serve than any other group, dedicating countless hours of their time every year participating in Fill the Boot drives and at MDA Summer Camp. We're grateful for the support of these inspiring, selfless individuals who have made a profound impact on our families' health, wellbeing and quality of life, and we're excited to make this year's Hiawatha Fill the Boot campaign the most successful yet."

Funds raised through 2014 Hiawatha Fill the Boot event will help support MDA's programs of worldwide research, specialized health care services, and day-to-day support - which includes sending children affected by muscular dystrophy and related diseases to a week-long, barrier-free

MDA summer camp at Camp Courageous in Monticello, Iowa. Last year, Hiawatha Firefighters raised \$9,339 for MDA and hope to increase that amount this year.

Bike Patrol

The Hiawatha Police Department began its bike patrol program in the spring of 2009. It was started with two officers attending the Iowa Law Enforcement Academy's one week long bike officer training class. The officers were outfitted with Cannondale police mountain bikes and appropriate bicycle patrol uniforms. The officers were instructed in the use of a police bike and how to ride a police bike in crowds, go up and down stairs, braking techniques, maintenance, and bicycle patrol tactics. Upon completion of this class, the two officers became certified bike officers. Another trained officer and bicycle were added in 2010 and another in 2011 for a total of four officers.

The bike patrol program has been a great asset to the department and the community when used for community events. It allows officers to have positive interaction with the public during these events like Hog Wild Days, parades, 5K's, color runs, bike rodeo, and Hibrai. At these types of events, it allows officers to respond to problems faster than on foot and where a patrol car cannot go. Night patrol with a police bicycle is also very effective as it allows for a silent approach.

The bike patrol has been a success for the police department and the community has benefited from the department having a bike patrol program.
