HEDGO ANNUAL STATE OF THE CITY



Mayor Theis welcomed slightly over 200 attendees to our fourth Annual State of the City on July 16 hosted by our Hiawatha Economic Development Corporation (HEDCO) and held at our regional Kirkwood Community Center on Boyson Road. HEDCO chair, Scott Gasway introduced Mayor Theis as Mr. Hiawatha describing his love for the community and his successes in economic development. "There's a reason why Hiawatha has the most companies on the Corridor Business Journal's list of Fastest Growing Companies because it's a great place to work and live. HEDCO works to support Hiawatha efforts and to create a positive climate for business here in "Hiawatha", said Mr. Gasway.

Mayor Theis spoke of the past years successes of voluntary annexations on the west side of I-380 on both sides of County Home Road and today the City is working on the design plans for installation of both water and sewer to over 133 acres. Mayor Theis spoke briefly about Center Point Road Zoning providing a floor plan for Hiawatha's future. "Zoning is an important element in economic development," said Theis.

2014 and 2015 has brought exciting new development up and down Boyson Road. Dave Wright Nissan/Subaru and the newly announced three story medical facility at 1195 Boyson Road (Duffy's) operated by Mercy Medical Center and further west near 18th Avenue two more office buildings are being constructed. Together these alone will bring over 200 new employees to the Hiawatha area. Mayor Theis said, "we are anticipating that it will encourage related development throughout our community."

Mayor Theis shared the Boyson Road/I-380 improvements plan is officially funded. The City will collaborate with the lowa Department of Transportation to begin design work this fall. The City continues to keep the Tower Terrace/I-380 Interchange on its forefront as the Interchange Justification Report is again for the third time in the hands of the Federal Department of Transportation with the support from our local Department of Transportation.

Mayor Theis also listed three new residential developments one that is in its last phase and two other developments that have recently opened with streets in place. Theis said, "full build outs of these areas will give Hiawatha 300 plus new homes. None of this would have happened if the City Council had decided not to provide water and sewer to this area. It's great to see the City grow again!"

To continue with Hiawatha's efforts in making it easy to do business with the City, Mayor Theis introduces an online permitting system that will allow contractors and homeowners to submit plans, applications and payments without making a trip to city hall. The portal will be accessible through the city website, which will expand in other services with an estimated startup date of January 2016.

Mayor Theis spoke of his excitement for RAGBRAI's overnight stay in Hiawatha on July 23. "We have an opportunity to show-case the City for about 24 hours. There are still people today that speak very highly of the 2004 RAGBRAI stay in Hiawatha. Let's hope this year's stay is even better!" Mayor Theis thanked the sponsorship businesses and those that are volunteering for the day. "We couldn't do this without you!"

Mayor Theis talked about expansion needs of a satellite fire station on the east side of I-380 and the library's overcrowded facility. The customer base continues to grow and because of that our facilities are filled to their capicity. The City has purchased land for a proposed satellite fire station along with committed Local Option Sales tax dollars to assist with funding needs.

In November, he anticipates taking this project to the voters. If such a referendum would pass, it would provide faster response times for the north and west sides of town, overnight sleeping quarters for firefighters and medical personnel and a training area. Also received was a petition to expand the Library's board members from five to seven members to help fulfill their needs as they move forward with future projects.





"Hiawatha's economy is strong, we have seen this through our growth to the north, direction of development in the heart of our community, residential and commercial growth, streamlining our processes for doing business, welcoming 1,000's of people to the community for RAGBRAI's overnight stay, community partnerships and lastly the need for city facility expansions," said Mayor Theis.

Joining Mayor Theis were keynote speakers: Speaker of the House Kraig Paulsen and Senator Liz Mathis. Together they spoke of legislative updates and their effects on doing business in Iowa. Paulsen and Mathis both spoke

of a balanced budget, revenue growth and the ability to refill the state reserves to a healthy number and provide economic development funding to support and stimulate business activity. The State's economy exceeded its goals this year and forecasted a strong economic future. They continue to fund job training along with supporting apprenticeships and internships to expand the employee field working through partnerships with community colleges like Kirkwood Community College. They both see the value of providing funding for high quality jobs and Innovation and Angel tax credits. "Focusing on innovation will help Iowa move forward and aid in Iowa's future," said Senator Liz Mathis.

May Surge In Construction Permits

Driving through Hiawatha you may have noticed an increase in construction activity. Along Boyson Road there are three new buildings and major remodeling on two other sites. These projects are part of a surge in construction permits in May which also includes a major remodel of the Hiawatha Elementary School for energy upgrades and installation of a geothermal heating system. The value of the projects issued permits in May exceeded last year's May valuations by 10 million dollars.

The surge included an upswing in residential construc-

alone. The total number of new home issued in the first six months of 2015 is equal to that of all



last year. The City has issued 12 new home permits with three more in the review process. With the final platting of Dell Ridge; another housing development, the preliminary platting of an addition to Pines at Turtle Creek and the recent completion of the final plat of Rolling Prairie, the housing increase is likely to continue.






On a Sunday afternoon July 12, members of the community joined Hiawatha Fire Department members in celebrating 10 years of ambulance service to Hiawatha and the surrounding community with an open house at the fire station.

In the fall of 2004, the city council voted to establish an ambulance service, operated by the Fire Department. The first ambulance was purchased shortly after, and responded to its first call in June of 2005. The Fire Department now has a total of three ambulances, all equipped with advanced life support equipment and medications. At the July 15, 2015 council meeting, council approved the purchase of a new ambulance for \$153,468 to replace the original unit that was purchased in 2005.







Having the ambulance service operate under the Fire Department within the City's Public Safety System, allows the EMTs, paramedics, firefighters, and police officers all to operate as one team, working closely to make Hiawatha a safe place to live, work and play. During the last decade, firefighters, EMT's, paramedics, and police officers have helped deliver babies, treat auto accidents, gunshot, stabbing, and fire victims, saved lives with our defibrillators, and provided advanced care to stroke and heart attack victims, saving countless lives. The Fire Department is proud of its accomplishments and looks forward to many more years of caring for the community.


Hiawatha Water Department Purchases an Asset Management Tool

Here at the Hiawatha Water Department, we like to keep up with today's technology to better serve our customers. Recently we have purchased two iPads with the WaterPoint network application from the company 64seconds. 64seconds specializes in mobile asset tools for municipal needs. This application allows the Water Department to enter information pertaining to the Water Department's infrastructure.

The Water Department uses the application as follows:

- → Tracking of yearly hydrant flushing information.
- → Pictures of each hydrant with specific hydrant information. **The WaterPoint application links a parts list for the hydrant brand to troubleshoot any problems with the hydrant. This allows water operators to quickly diagnosis and fix any hydrant issues.
- → Keep measurements and pictures of water main valves and curb stops.
- Assist in our Meter Change Out Program. **water operators take pictures of each meter installed and document corresponding meter numbers for specific addresses. This is to verify field information and office information are correct.

If you see one of our water operators clicking away on an iPad, you will know they are working on the WaterPoint Network to keep Hiawatha Water Department's infrastructure up to date.
