# Mayor's State of the City Address 2011

2011 has been a very good business year for Hiawatha. Our focus was to find a way to grow Hiawatha and enhance current infrastructure.

The Council did just that by promoting Tax Increment Financing (TIF) in economic development and investments in one old and several new infrastructure projects.

"Go Daddy" spent over \$500,000 to remodel their building at 1 Parsons Drive before moving in and the City provided them some assistance. Since the official Grand Opening held on July 8, 2010, they have conducted several "job fairs" searching for new employees. Current employment numbers are 583 and the goal is set for 592 employees after the first of the new year.



We saw one major economic development project through the construction of a 40,000 square foot, \$5M building for PAETEC (Windstream); that retained their 400 plus employees in Hiawatha.

2011 also saw the construction of six (6) new commercial buildings in Hiawatha. Four of those are single business owners and the other two (2) buildings will house multiple businesses. We are very fortunate to have developers and businesses that are willing to look at our City's quality of life and work environment. CCB Packaging added a 40,000 square foot warehouse expansion, 7,000 square foot corporate office addition and hired 40 new employees. Tower Commerce and Technical Park, located off Tower Terrace Road and Hawkeye Drive, have begun development of streets and construction of a 12,753 square foot building for Dancer's Edge, a cell tower and recently announced, Enseva LLC Data Center.

Diversity of residential growth is just as important as commercial growth to our City. In 2009 and 2010 Hiawatha had two (2) voluntary annexations of approximately 500 acres. It is important to note the City of Hiawatha does not annex land and not provide city services; so we had a big job ahead of us in providing this area with water and sewer infrastructure. The City's investment of \$3M to install water and sewer services is paying off, with a new avenue for residential growth, attracting several new home contractors to Hiawatha with the addition of 13 new homes and a current return on our investment of \$1.7M in 2011 in property evaluations alone.

Several years ago, the City embarked on an aggressive sanitary sewer repair program. After televising and grouting some major trunk lines, we are seeing a significant reduction of clean water infiltration, which is reducing our charges from the metro waste water treatment plant. Some of this work has been paid for with Local Option Sales and Service Tax funds, such as 3rd Avenue and C Avenue that have been updated with both sewer and water line improvements and a nice new street to go along with those needed improvements.

Two additional street improvements have been completed this year. The \$2.3M North Center Point Road Reconstruction Project is complete and open as of November 2011. Stamy Road has also been newly paved. Both projects received RISE grants from the State of Iowa. With a RISE grant, the Iowa Department of Transportation becomes a 50/50 partner with the City in cost sharing of the project. The North Center Point Road Reconstruction Project qualified for RISE grant funds, because of the CCB Packaging expansion of a 40,000 square foot warehouse, 7,000 square foot corporate office addition and hiring of 40 additional employees. Stamy Road qualified because of the potential commercial development and added jobs in the new Tower Commerce and Technical Park located off Tower Terrace Road and Hawkeye Drive. The developer additionally installed two (2) new streets in the park; Commerce Boulevard and Mentzer Drive.

In an effort to continue with enhancements to infrastructure, the City of Hiawatha has combined efforts in promoting the Tower Terrace Interchange Project with the cities of Robins, Cedar Rapids, Marion, Linn County, and the entire northern metro corridor. There are two main benefits of the I-380/Tower Terrace Interchange; promote economic development and traffic relief on Blairs Ferry Road and Boyson Road.

In June of 2011, the Iowa Department of Transportation authorized a new Interchange Justification Report (IJR) for the I-380/Tower Terrace Road Interchange. The study should take about 12 to 18 months and includes the environmental aspects of the project. We are hopeful the concerns expressed in the 2006 report have been corrected and we can take positive steps forward to a new connection with I-380.

The City has purchased right-of-way property along Boyson Road to begin needed utility work to prepare for the construction of the Boyson/Robins Road Intersection Project. Engineering of the intersection is being done at this time and hopefully construction can begin in 2013. This will be a signalized intersection with turn lanes and should help with the flow of traffic on Boyson Road. Other improvements to Boyson Road will be done as development occurs in the area.

The Hiawatha Town Center Plan has been in the making for a number of years with established phased plans for development. The New City Hall became Phase I. The purchase and cleanup of the former Oakbrook Mobile Home Park has moved us much closer to Phase II, while the Council has been very deliberate in how the area should be redeveloped. The current proposed plan looks very promising but there are many details to be reviewed and worked out at this point.

The reconstruction of Emmons Street/Robins Road Intersection will round out the central part of our plan. Once the details are worked out and the plans are finalized, we will be sharing them with everyone.

Along with sanitary sewer, water and street projects; Local Option Sales and Service Tax has been an additional asset to our community; such as the purchase of a new fire rescue unit, updated police K-9 unit, and park improvements. Those happened because you passed the five (5) year Local Option Sales and Service Tax. I hope you feel we are doing a good job of distributing these funds.

We have been very progressive and detailed in our efforts to grow Hiawatha's future; in both residential and commercial development; and responsible in our infrastructure needs by repairing and maintaining older water and sewer infrastructure and adding new in areas where it is needed for future development. The City will continue to enhance and promote our need to grow, balance our budgets and maintain a reasonable levy rate for its citizens and business owners.

# Resident Survey Results

In September's newsletter, we asked our citizens to complete a ten (10) question survey. The questions asked your opinion of what you felt about the City's infrastructure, Park and Recreation facilities, your view of our City government and what our City's priorities should be.

210 residents responded, of those, 84% rated our infrastructure as excellent to fair; 91% rated our Park and Recreation facilities as excellent to fair; access to City government was rated highly at 92%; Staff was rated as 93% accessible to the public and 90% of the respondents felt the City website, newsletter, and press releases kept them informed of pertinent and up-to-date information. Residents response to the opinion of what the Council's top four (4) priorities should be are as follows:

- Continued city street improvements and maintenance
- Increase commercial business in town (hotels, restaurants and retail)
- Keep crime rates down
- Keep property taxes down

## Fay M. Clark Memorial Park

In 2008, the Fay M. Clark Memorial Park was dedicated to the memory of Fay Clark, Hiawatha's founding father and long time Mayor.

The park contains a pavilion, restrooms, a nearly one mile long trail, a disc golf course and playground equipment.

A walk bridge was put into place on the trail. The bridge was made from the rafters taken out of the Quonset structure, which was the first business building in Hiawatha in the 1940's.

Recently a memorial rock has been placed on the trail by the bridge. It is to be engraved as a memorial to the bridge and Fay Clark.

Fay M. Clark Memorial Park is a beautiful park to come and spend time playing disc golf, walking, getting together for a picnic or just relaxing and enjoying our newest park.

You may even see a deer or two while walking the trails in the early morning or early evening hours.

## Hiawatha Fire Chili Supper Recap

This year the Hiawatha Fire Department hosted it's annual chili dinner November 5th. Approximately 780 people attended the event this year. Over \$5,000 was raised. Planning for the event starts weeks earlier. On Friday, roasters are made up with the secret recipe, and then simmer overnight.

The proceeds from this year's chili event will go toward the purchase of new rescue equipment. In the past, donations have been used to purchase a new thermal imager camera, which allows firefighters to see through smoke. The new camera has much improved technology, improving our ability to save lives and reduce property losses. The new camera costs around \$10,000, and was purchased last winter. The Fire Department has also combined donated money with L.O.S.S.T. funds to purchase simulation mannequins that allow EMT's to practice medical skills in a realistic setting. Thanks to donations, grants, and L.O.S.S.T. funding, the department now owns both an adult and child mannequin. The FD hopes to use funds from this year's supper to purchase additional medical and rescue equipment.

The Fire Department wants to extend a special thanks to Betty Mark, who spends countless hours tracking down donations for both food and door prizes. Without her support, we wouldn't be able to have the large door prize giveaways.

Thanks to all of you who came out and supported the event, and to all the business partners who donated supplies, and money to make the event happen!

## Eagle Scout Project in Memory of James & Jeannette Faas

An Eagle Scout project has been completed by Adam Walker in memory of James & Jeanette Faas. A new bench with path and landscaping has been placed in Fay Clark Memorial Park. The children of James & Jeanette Faas donated the funds to the City for this memorial bench and tree planted nearby. A plaque will be ordered with their names to be placed on the bench.

Jim and Jeannette Faas came to Hiawatha in 1946. Fay Clark needed a welder and that is what Jim had done during the war. Jim built the first water tower and the first fire truck. Jim welded Jeannette's name on the inside of the water tank.

Jeannette worked in the truck stop and later, they started the first grocery store, on the corner of Fisher Street, where she worked.

Fay was trying to start a town, so he would give away land lots to people, who would use them to build houses. That is how Jim got his first lot to start building houses in Hiawatha. Jeannette did the painting, staining and varnishing. In the early days, she even helped with shingling. In the late 1950's, Jim started his own business, Hiawatha Plumbing and Heating.

They started in a small house, close to Center Point Road and continued building houses and moving west as the town grew.

They spent their adult lives in Hiawatha, working and raising three (3) children. Jim was on the fire department and was the Fire Chief in the early days, on the Water Board for many years and finally, after retiring from building homes, was the Hiawatha Building Inspector. Jim passed away in 1999 and Jeannette in 2011.
