Comprehensive Plan 2036 Summary

The City of Hiawatha has completed work on the proposed 2036 Comprehensive Plan. The document was presented for recommnedation to the Planning and Zoning Commission on November 28, 2016. The plan was approved by the Commission and presented for Public Hearing at the City Council meeting. City Council approved the plan following the public hearing on December 21, 2016.

The previous Comprehensive Plan for Hiawatha was written in 2010. Since that time, the city has experienced significant growth, annexed more land and established the Center Point Road zoning districts. These changes made it imperative we re-evaluate the goals and strategies and clarify our vision for the community development.

The planning and visioning process included five project-team meetings and four public meetings. The public meetings included the hearings before P&Z Commission and the Council. Additional input was received through an on-line survey and mapping tool in which citizens were allowed to contribute concerns and ideas regarding the future of Hiawatha. One public meeting had about 50 people in attendance and the on-line mapping tool have over 200 participatory hits. The *vision statement* developed through this process encapsulates the unique role of Hiawatha in the Northeast Iowa corridor:

We are the Creative Corridor's most welcoming community to live, work and experience. Residents and visitors love our small town feel, walkable neighborhoods and the unique restaurants and shops in our vibrant Village Center.

Public input and statistical analysis indicates Hiawatha has immense growth potential and faces some very important issues moving forward. Statistics indicate we only have about 50% of the required owner occupied and rental housing units needed for our residents with incomes from \$25K to \$50K. This group of people includes young professionals desiring to get established in our area.


Additionally, Hiawatha is projected to need an additional 50% increase in overall housing stock in the next 20 years. This is about 1,600 units. Without adequate available housing our labor market may be adversely affected limiting the potential growth of our commercial and retail segments.

Another major issue faced by our community is traffic and transportation challenges. This issue ranked as a high priority in all of our surveys. Though it is an asset to have an interstate highway within our community we are not able to take full advantage due to limited access points. An additional interchange at Tower Terrace, a redesigned interchange at Boyson Road and the new intersection at North Center Point Road/Emmons/Robins Road will serve to relieve the traffic pressure on residents and workers of Hiawatha.

The citizens of Hiawatha feel it is very important to manage growth through a balanced land use plan for commercial and residential uses. Our surveys noted the desire for outdoor and public amenities along with the development of commercial retail centers and restaurants. The concept of the village centers ranked high in providing ready access to these services. The village center concept includes developing high density multi-family units in and around centers of commerce. This describes our Center Point Road zoning objectives.

The significant opportunities reflected in this plan include meeting housing needs, designing transportation strategies, designating zoning potential for an extended area around Hiawatha and a strategic goals format for monitoring our progress towards the 2036 vision. The new statistical information along with our vision gives us the necessary guidance and rationale for moving forward with our strategic goals.

With this plan, city staff and elected and appointed officials will be able to make appropriate decisions regarding land use, development and enhancement of our City amenities such as parks, trails and public services. The plan will guide and coordinate our efforts to update our Unified Development Ordinances and strategic plan. Knowing we desire to be a growing community with a "small town feel" and that we are integral part of the larger "corridor community" will keep our perspective focused on the present and future needs of our residents with a plan to accomplish that vision.



North Center Point Road/Emmons Street/Robins Road Intersection Improvement Phase II



The second phase contract awarded to Rathje Construction Inc. of Marion is now complete from Fisher Street to approximately 300 feet to the south. The total project will move the existing Emmons Street/Robins Road/North Center Point Road intersection approximately 100 feet to the northwest. Included will be new intersection paving, traffic signals, multi-use trail, bus stops and street lighting. The construction is shut down for the winter months and all lanes are open to traffic.

Target project completion date is November 2017.

Three New Additions Completed in 2016

The construction is now complete on three new subdivisions in the City of Hiawatha. Dell Ridge 2nd Addition and Heritage Green 12th Addition add new residential lots. R&S Addition adds four new industrial lots. Construction of new residential homes and new commercial buildings continue at a fast pace and appears to be strong leading into 2017.

Water and Sewer Extension Project Complete to Newly Annexed Area

The construction of the sewer and water main extension to the newly annexed area along Edge-



wood Road between Fitzroy Road and County Home Road is now complete. Over 5,000 feet of 12" water main, 2,700 feet of 8" sanitary sewer and 4,000 feet of 8" pressure line has been constructed. This will now open approximately 300 acres to future development.

Water Main Break Information

Here at the Water Department we know the importance of having water available when you open the tap or flush a toilet. We also understand the frustration you experience when the water is not present. It's that time of year when water main breaks may occur. The Water Department wants to make sure our residents know what to do if or when this happens.

When a water main break occurs it requires the Water Department employees to close down several water main valves to isolate the main and control the leak. We do our best to inform our customers when a water main break occurs. Sometimes, actually many times, these main breaks are emergencies or they occur after hours and our customers don't become aware of the leak until water is not available.

Rest assured, the Water Department employees will be working diligently to find the source of the leak and correct the issue to reestablish water to your property in a timely manner. We appreciate your patience when a situation like this arises.

If you should see or suspect a water leak, please report it to the Water Department at 319-393-5556 opt #4. If it is after business hours please contact the non-emergency Police Department number 319-393-1212. We will promptly investigate the concern.

Wintertime Fires and Safety Tips

"Baby, it's cold outside" rings true this time of year. For firefighters, cold weather brings on the challenges of working in sub freezing weather. Protecting shivering victims who are standing outside their burning home in night clothes becomes a high priority for police and firefighters arriving. The heat of the fire will turn to wind and cold once the fire is extinguished. Water that poured from the hoses to put out the fire is now covering everything as ice, adding pounds to firefighters gear, making hoses hard to move and turning the fire scene into one giant ice rink. For firefighters, it's more than that. Cold weather also brings on a variety of fire hazards that increase this time of year. Heating devices ranging from wood stoves to heat lamps can create a fire hazard. Dry Christmas trees can go up in flames in just seconds. In the excitement of the holidays, a candle knocked over can become a fast growing fire. With that in mind, the Hiawatha Fire Department would like to offer a few seasonal fire prevention suggestions. Don't believe it will happen to you? All of these suggestions resulted from fires in Hiawatha in the last several years:

- Space heaters need space: having 36 inches of clearance around all heating devices is recommended. Space heaters, wood buring stoves, ovens, even heat lamps all need space. A heat lamp used to create a warm spot for pets can fall into bedding and cause a fire. Remember to turn off your space heater when you leave a room.
- When emptying ashes from your fireplace or wood buring stove, put them in a metal bucket, outside your home, away from anything that
 can burn. Ashes can hide smoldering embers days later and a plastic bucket, trashcan or cardboard box will burst into flames when the ember
 finds its way.
- Smoldering cigarettes can create a similar hazard. Make sure the ashes are out before dumping an ashtray in the trash can. Dispose of cigarettes properly, a smoldering cigarette can ignite dry grass or leaves (when there isn't snow on the ground).
- Candles: keep candles on a firm surface, away from things that can burn. Remember to blow candles out
 when you leave the room.
- When cooking on the stove top never leave the room. If you have to, set a timer or take a spoon with you to help you remember you are cooking. If you have a grease fire, "put a lid on it." Turn off the stove and smother the fire with a lid or damp towel. Don't try to move the pan and never put water on a cooking fire. If the fire is in your oven, simply turn off the oven and leave the door shut. The oven is designed to take that heat and the fire won't "get out" of the oven. Most of all, call 9-1-1 and wait outside. There is never a charge and even if the fire is out, we can blow smoke out reducing the smoke odor in your home.
- Properly dispose of dry Christmas trees. A dry tree will burn rapidly, destroying everything and making it hard to escape.
- Check your smoke detectors. Remember to check your smoke detectors once a month, replace the battery
 once a year and replace the detectors every 10 years.



Another Good Neighbor Policy: Outside Storage

One of our business owners affectionately refers to our city as "Beautiful Hiawatha" in their advertising campaigns. The visual aesthetics of our cityscape is one of the values espoused in our Comprehensive Plan and reflected in our ordinances.

Our Comprehensive Plan references visual elements in the Land Use Section, Quality of Life Section and the Community Character Section. All of these items point to detailed landscaping requirements, building designs and site aesthetics which enhance the beauty of Hiawatha. Items include specified building materials, night sky lighting, green space and screening of storage and garage areas. This is evidence we care deeply about how our city looks.

Consequently we have put in place ordinances which reflect this concern especially regarding outside storage, garbage and junk vehicles. It is generally expected that no outside storage is permitted unless specifically allowed in an ordinance and no junk vehicle is allowed only in specifically designated parking areas. The regulations differ between commercial property and residential property.

Outside stored materials which are classified as garbage, trash, solid waste and junk vehicles are specifically prohibited and are considered a nuisance. (*Hiawatha Ordinance Chapter 50, 51 and Hiawatha Property Maintenance Code Chapter 164*). These items are to be properly contained, removed from all property and properly disposed. Additionally, all dumpsters and waste storage areas for commercial property are to be surrounded by an enclosure. (*Hiawatha Ordinance Chapter 106*).

Outside storage not described above is regulated in our Unified Development Code (UDC) Chapter 165. This section of the code prohibits storage of any kind; including junk vehicles, in the front yard of a residential property. Further, all outside stored materials are to be properly screened.



165.23 (9) C. Parking and Storage Restrictions.

(7) Outside Storage. Outside storage shall not be permitted in any required yard. Outside storage shall not be permitted in any front yard in a Residential District. All outside storage shall be effectively screened with landscaping and building elements or opaque fences or walls from the right of way and from off-site views......(to view the entire section, go to www.hiawatha-iowa.com - city ordinances are found on the home page).

When we accumulate more "stuff" than we can hope to store within our residence, garage and storage buildings, we must keep our neighbors and the well being of our city in mind. If you need to store items outside, remember this good neighbor policy. Eliminate any unnecessary outside storage and properly screen the stored items which cannot be eliminated. Help us keep "Beautiful Hiawatha" beautiful!

2016 Annual Legislator Meeting

On December 21, Mayor Bennett and Council Members Marty Bruns and Aime Wichtendahl and City Staff meet with Senator(s) Liz Mathis, Dan Zumbach and House of Representative Elect Ashley Hinson. There are many benefits to meeting throughout the year with our legislators; one is to build positive relationships and discuss concerns with legislation we believe will affect the city's budget and overall functionality and our ability to maintain home rule. Lastly, to ask for their help and guidance with new initiatives.

This year top of mind discussions were to place the Tower Terrace Interchange project in IDOT's funding within their five year plan, maintain commercial property tax backfill appropriations, stance on minimum wage, promotion of skilled workforce, setting reasonable limits on body camera storage and open records, maintain city's home rule on right-of-way issues with cellular companies and the potential of writing a bill that addresses Ground Emergency Medical Transport reimbursement funding for Hiawatha EMS and other communities in the state that provide such services.

Senator Zumbach briefly discussed the State's initiatives to review the State's tax structure as a whole while Senator Mathis and Representative Hinson spoke of their efforts in maintaining a skilled workforce and the need to remain competitive by creating an environment that promotes competition along with encouraging programs that promote "Welfare to Work" and higher education.

Linn County Minimum Wage in Effect

As of January 1, 2017, Linn County Minimum Wage is in effect. The City of Hiawatha City Council supported Linn County's Minimum Wage Ordinance #4-9-2016 with an increased hourly wage of \$8.25 to provide consistency throughout Linn County boundaries. The Hiawatha City Council will review each additional annual minimum wage increase thereafter on its own merit. The City Council in their discussions also urged our Iowa legislators to take a step forward to adopt a minimum as a whole; providing consistency throughout all of Iowa and to encourage a culture of work and a level playing field for the rising generations.
