# **City Election 2015**

The City of Hiawatha is preparing for a regular city election to be held on November 2, 2015. City elections in Hiawatha are held in odd-numbered years and elected officials serve a four-year term. The following offices will be on the ballot for this year's election:

In order to hold a public office an individual must meet the same qualifications required when registering to vote, be at least 18 years of age and reside in the city they wish to represent. Hiawatha is a Chapter 45 city which means candidates running for office are nominated by petition with a requirement of not less than 25 signatures. The candidate's petition must include an Affidavit of Candidacy including candidate name, residence and statement of elgibility for office and if elected, the individual will qualify for office. Circumstances making a candidate ineligible are felony convictions and mental instability. Candidates' signatures must be witnessed by a notary public.

Nomination papers can be picked up at the City Clerk's office, Linn County Election Office or individuals can visit the election section of the Secretary of State's website at sos.iowa.gov for additional information. **Due to new legislation approved in 2014, candidates must file nomination papers with the county auditor instead of the city clerk.** 

# Important Dates on the Election Timeline:

August 24, 2015 First day to file nomination papers with the county auditor

September 17, 2015 Candidates must file nomination papers in the office of the county

auditor by 5:00 p.m.

November 3, 2015 Regular election day (polls open 7:00 a.m. - 8:00 p.m.)

# Emmons Street Railroad Crossing Repair

The City of Hiawatha has been working with the CN Railroad and the Iowa Department of Transportation to improve the railroad crossing at Emmons Street. A new rubberized crossing was installed last year with the anticipated new paving approaches installed this year. A temporary approach has been installed until the final project can be completed.

Along with this construction, drainage concerns along the railroad tracks between the new crossing

repair at North Center Point Road and the existing Blairs Ferry Road crossing are being addressed. A report prepared by the railroad outlined many areas of what was identified as erosion along the tracks that could lead to damage of the track base and ballast. The Emmons Street crossing also contributed to the erosion issue as the drainage pipes installed in the 1970's during the interstate construction were not large enough to accommodate the amount of surface water that flows to the area. During large rain events, the water flows over the road that can also lead to damage of the street and the railroad tracks.

The project underway will stabilize the embankments with stone protection and will also replace the Emmons Street crossing with new paving with larger drainage pipes. The City intends to reconstruct the street at the crossing to coordinate with the new track elevation with a much smoother riding surface and new accomodations for pedestrians. Also, a plan for a new future railroad "Quiet Zone" will be a design element for the reconstruction. The construction work has begun with approximately 30 days planned for the embankment stabilization and the Emmons Street crossing replacement scheduled to take place in August.

- You call us at least 48 hours (excluding Saturdays, Sundays and legal holidays) before any excavation.
- 2. We notify underground facility operators.
- 3. The underground facility operators mark the lines.
- 4. You dig safely.





# **Parking and Storage Changes**

EMMONS ST

On May 6 City Council approved changes to the Parking and Storage Regulations in the Hiawatha Code of Ordinances. Most of the changes clarified existing requirements for parking and storage. All vehicles, machines and equipment are still required to be parked on a hard surface with two new exceptions. Heavy equipment in industrial zones may be parked on rock or gravel and "Outdoor displays" in commercial zones are permitted on any surface.

Outdoor display areas shall be considered exclusive to required parking and driveway areas. This new concept requires a hard surface for parking unless the display is removed when the associated business is closed. The display areas must also be out of the right of way and properly maintained to prevent erosion, weeds and unsightly appearance. Existing outdoor displays which do not comply with these regulations have 3 years to achieve compliance.

There have been two changes to the outdoor storage regulations. First, in residential zones outside storage is no longer allowed in front of a single or two family dwellings. Second, in industrial zones outside storage may be on rock or gravel. In all other commercial zones all outside storage is still required to be screened from public view and to be on a hard surface.

(NOTE: No parking, storage or display areas are allowed in the Corner Visual Clearance area).




The Water Department has recently added a new piece of equipment to its inventory. It's a SeCorr 08 Leak Detection correlator. This device will help the Water Department staff

locate water leaks in the distribution system. When water leaks occur in the piping during the winter months or under the concrete street, it becomes difficult to locate them. With this new Leak Detector it will pin point leaks and save time and money in repairing the leak.



# Free Wi-Fi in City Parks



The City and ImOn Communications, LLC have entered into a partnership to provide free Wi-Fi at each of our City Parks. This partnership is an opportunity for the City to improve our park connectivity and furthering our efforts to expand our parks amenities & enhance our goers experiences.

ImOn will construct 4 hot spots within the parameters of each park. The new network will provide a 2 hour window each day for all our park visitors. The total project cost consists of \$46,047 for materials. Our responsibility is 50%. The estimated completion date is set for the second week of July.

ImOn will select & order the required equipment, configure & program the equipment & install. ImOn will monitor the equipment & provide 24X7 network support including maintenance & repair at no cost to the City. ImOn will deliver an adequate internet gateway bandwidth to all access points providing Wi-Fi user login/terms of service page, authentication & landing page development for hosting.
