Hiawatha Asks for a Continued Partnership with the IDOT

On April 9, 2013 Mayor Theis asked the lowa Department of Transportation (IDOT) to continue their partnership with the I-380/Tower Terrace Interchange.

The IDOT has provided financial assistance in the reconstruction of three (3) sections of streets in the amount of 2.3M.

- 2010 North Center Point RISE Grant.
- 2011 Stamy Road Expansion RISE Grant. 2012 North Center Point RISE Grant.

Together we have improved and enhanced economic development by welcoming new businesses and expansions in these areas with an increased taxable value of 14.8M and maintained/created 400 jobs within our community.

Now, with the new IJR for the I-380/Tower Terrace Road Interchange appearing to be favorable with caveats, we wanted to remind the IDOT of its importance to all our metro communities.

The interchange is proposed to be a standard diamond design that is used in most all the cities in Iowa. The City is very happy with this option and we think it will serve our community for years to come! The IJR estimated cost is \$16-20M.

The benefits are many:

- It supports our regional transportation needs of several communities: Hiawatha, Robins, Cedar Rapids, Marion and Linn County.
- Supports economic development.
- Helps with current and future traffic demand on Boyson Road and County Home Road interchanges with I-380.
- Reduces traveled miles, lessens congestion, and improves safety.

Our partnership would look something like this - Hiawatha will continue to:

- Increase public awareness and develop Metro area partnerships.
- Seek and secure finances with our local jurisdictions, and the MPO.
- Earn the earmarking of our congressional leaders for funding.

The City is asking the IDOT to provide feedback and guidance on project financing and development, and partner not only with the City but with metro jurisdictions as well.

Storm Water Advisory Committee

With continued concerns about flooding and storm water development, a new advisory committee was formed to advise our community and advocate for changes in ordinances and implementation of best storm water management practices including to protect water quality and as important an objecture to reduce the quantity of uncontrolled run off.

Currently our members consist of City Staff: Community Development Director, two (2) Building Officials and the Engineering Coordinator. These individuals possess great knowledge and skills but to be successful, the City is in need of citizens input.

The Committees priorities include:

- A plan to restore the flood plain and control run-off.
- Develop the best storm water management practices putting them where you can.
- An improved communication/education and ordinance proposal to make a difference.

2013 Mosquito Control Program

The control of mosquitos is a major concern. Without control programs, the mosquito population would flourish and cause potential health and comfort issues.

From a health standpoint, mosquitos are known carriers of encephalitis, yellow fever, malaria and dengue virus. Mosquito-borne diseases cause more than one million deaths each year around the world. This results in the need for adult mosquito control.

The City will receive a combination of treatments from the Integrated Pest Management (i.e. larvaciding, barrier, adultciding) treatments based on NPDES permit through the program season. Depending on the weather and species of mosquitos that they encounter, the treatments will be selected from the control methods to provide the City with the best results available. This is the City's 8th year of providing this service.

Spraying will tentitively occur between Monday evenings and Saturday mornings depending on the weather. Mosquito Control of Iowa will begin sprays in May as long as the temperatures and wind speeds are at acceptable levels.

Due to concerns about pesticide exposure, Mosquito Control of Iowa will maintain a list of those residents who wish to be notified of when spraying will occur.

Community Development Department - Pet Waste Pollutes!

It might not seem like a stormwater problem, but animal waste is one of the many seemingly small sources of pollution that can add up to big problems for water quality and even human health.

Animal waste contains two main types of pollutants that harm local waters: nutrients and pathogens. When this waste ends up in water bodies, it decomposes, releasing nutrients that cause excessive growth of algae and weeds. This makes the water murky, green, smelly, and even unusable for swimming, boating, or fishing. The pathogens, disease-causing bacteria and viruses, can also make local waters unswimmable and unfishable, and have caused severe illness in humans.

As you can see, animal waste doesn't simply decompose. So the easiest way to avoid these problems is to clean up after your pet each and every time, and dispose of the waste properly.

Annual Budget Report

At the March 6, 2013 regular meeting, the City of Hiawatha City Council adopted the new budget for the upcoming Fiscal Year 2014 that will begin July 1,2013. Department managers and council members began budget discussions last fall by setting priorities and goals for the coming year.

The City of Hiawatha's elected officials have weighed the needs and benefits of projects and services against their associated costs. Some of the projects included in the Fiscal Year 2014 budget include water, sewer, and storm sewer improvements, updates in the park and recreation department, library, fire and ambulance service, and the police department.

The tax rate will change from last year's rate of \$15.15 to \$15.18 per \$1,000 of assessed taxable valuation for the Fiscal Year 2013-2014. The City's tax levy is a very important part of the residential property-tax equation. A property-owners tax bill is determined when Linn County Assessor values a property and the state sets a "rollback", or what percentage of the value of property is subject to tax. The property value is then multiplied by the levies of the other jurisdictions with taxing authorities, such as the State of Iowa, Linn County, local school districts and Community Colleges.

Project Updates


The City of Hiawatha began the reconstruction of the Boyson Road and Robins Road intersection on Monday, April 15, 2013. The intersection will be closed in four stages with the following anticipated schedule:

Stage 1: Close and reconstruct Boyson Road east of Robins Road from 4/15/2013 - 5/23/2013.

Stage 2: Reopen Stage 1 to local traffic. Close and reconstruct the intersection beginning 5/27/2013 to 6/27/2013. Stage 3: Reopen Stages 1 and 2 to all traffic. Close and reconstruct

Boyson Road west of Robins Road beginning 7/1/2013 to 8/2/2013. Stage 4: All roads open to traffic. Install traffic signals, sidewalk and seeding beginning 8/6/2013 to 8/29/2013.

The City of Hiawatha began construction on the North Center Point Road Reconstruction project on Tuesday, April 2, 2013. The phases are as follows:

Phase 1: Underground Utilities, Joint Trench, Water Main, Storm Sewer, Grading West Side beginning 04/02/2013 - 05/25/2013. Phase 2: East Side Temporary Paving, West Side Half Street Paving beginning 5/24/2013 - 7/15/2013.

Phase 3: Close Parsons Drive, complete East Half Paving beginning 7/16/2013 - 8/16/2013.

Phase 4: Landscaping, Electrical Work Both Sides beginning 8/14/2013 - 9/6/2013.

Phase 4: Complete Trail, Parsons Drive, Open Parsons Drive begin-ning 9/9/2013 - 9/13/2013. Phase 4: Finish Seeding, Sodding, Plantings and Landscaping begin-ning 9/13/2013 - 10/25/2013.

Phase 5 is the work next to the Railroad and dependent upon the Railroad's schedule for the crossing improvements.
