Snow Ordinance Changes That Affect You

Changes for snow and ice control are in store for the 2009-2010 winter. The City has made the rules easier to follow by using the 24 hour predictions of the National Weather Service (NWS). The City will also monitor other local sources, however, the NWS officially becomes our backbone for planning efforts. Residents should know we unofficially have used this tool in the past and are now making the NWS part of our policy.

Remember - Don't park in the street if:

The 24 hour (or less) prediction by the NWS is for three (3) or more inches of snow,

Three (3) or more inches of snow has fallen and/or your street has not been cleared.

Also, the City will <u>not</u> generally conduct snowfall clearing operations for a snowfall of less than two (2) inches. This policy remains unchanged from prior years.

Be Prepared! Winter is Coming!

Safe Winter Driving Tips

<u>Clear snow and ice from all windows and lights</u> - even the hood and roof - before driving.

<u>Pay Attention -</u> Don't try to out-drive the conditions. Remember the posted speed limits are for dry pavement.

Leave plenty of room for stopping - Brake early. It takes more time and distance to stop in adverse conditions. If your car is equipped with antilock brakes, do not pump brakes in attemption to stop. The right way is to "stomp and steer!"

Leave room for maintenance vehicles and plows - The law requires you to slow down or move over when approaching emergency or maintenance vehicles, including snow plows, parked on the side of the road when they have their flashing lights turned on. If you approach a parked emergency or maintenance vehicle during a winter storm and decide to change lanes be extra careful. The passing lane may be in worse shape than the driving lane. There may also be a snow ridge between the two lanes. Avoid making an abrupt lane change. If approaching a snowplow, stay back at least 200 feet (at least 15 car lengths) and don't pass on the right. Snowplows plow far and wide - sometimes very wide. The front plow extends several feet in front of the truck and may cross the centerline and shoulders during plowing operations. Plows turn and exit the road frequently. On multiple lane roads, watch for snowplows operating in either lane. Snowplows can throw a cloud of snow that can reduce your visibility to zero in less time than you can react. Drive smart. Never drive into a snow cloud - it could conceal a snowplow. A snowplow operator's field of vision is restricted. You may see them but they may not see you.


Know the current road conditions - Call 511 or log onto the Iowa DOT winter road conditions web page. www.iowadot.gov.

Watch for slippery bridge decks - even when the rest of the pavement is in good condition. Bridge decks will ice up sooner than the adjacent pavement.

Don't use your cruise control in wintry conditions - Even roads that appear clear can have sudden slippery spots and the short touch of your brakes to deactivate the cruise control feature can cause you to lose control of your vehicle.

Don't get overconfident in your 4x4 vehicle - Remember that your four-wheel drive vehicle may help you get going quicker than other vehicles but it won't help you stop any faster. Many 4x4 vehicles are heavier than passenger vehicles and actually may take longer to stop. Don't get overconfident in your 4x4 vehicle's traction. Your 4x4 can lose traction as quickly as a two-wheel drive vehicle.

<u>Look farther ahead in traffic than you normally do -</u> Actions by cars and trucks will alert you quicker to problems and give you an extra split-second to react safely.



Drive with your headlights on.

<u>Go slow</u> - especially when approaching intersections, off-ramps, bridges or shady spots. These are all candidates for developing black ice - a thin coating of clear ice that can form on the pavement surface and may be difficult to see.

Tips On Snow Removal

<u>Please</u>, <u>please</u>, <u>please</u> - do not push, plow, pile, or deposit snow from your residential or commercial driveway, sidewalk, or parking lot onto the street. This is against our City Code to do this under Chapter 135.12. This includes pushing snow from your driveway across the street into your neighbor's right-of-way. The city snow plows will have to make extra passes to clean this up and the snow will end up in your neighbor's driveway. Try to keep driveway and sidewalk snow in your yard behind the sidewalk. Save as much room as possible in the right-of-way for street snow. If you have a contractor plow your driveway, sidewalk, or parking lot, please inform them of this. If you have no place to put the snow then you will have to have it hauled away. We will be issuing warnings and possible fines to violators. It is recommended that you do not clear the end of your driveway till the street has been cleared.

<u>Property owners</u> - have 24 hours to remove snow from their sidewalks after the cessation of snow fall, City Code Chapter 136.03. The City can remove the snow and assess the costs to your property taxes. Bear in mind this is contracted out. This is required so pedestrians and school children can have safe routes to walk on. If you want to report a sidewalk that needs to be cleared, call 393-1515.

<u>Check your mailbox</u> - be sure that your mailbox is BACK of the curb line, preferably about six inches, City Code Chapter 135.14. If a plow hits your mailbox and/or post, buy a new one if needed and bring the receipt to City Hall for reimbursement up to \$50.

<u>You can help out</u> - the Water Dept. and Fire Dept. by clearing snow from around fire hydrants that are near your property. This makes it easier for the firemen to find during emergencies.

<u>Check with your neighbors</u> - especially the elderly, to see if they need help with shoveling their sidewalks and driveway. It's a great way to build community spirit and check on neighbors.

<u>Keep your vehicles</u> - in your driveway or parking lot during snow events, per Hiawatha Code of Ordinances, Chapter 69, Parking Regulations. This makes it easier for the plow trucks to clear the street curb to curb.

<u>Direct sump pumps and downspots away</u> from hard durfaces so that water doesn't build up and freeze creating slippery conditions on driveways, sidewalks, or streets.



























Right-Of-Way...More Than a Street

Recent questions regarding the use of right-of-ways prompted a review and subsequent revision of the municipal code to make the purpose and definition of the right-of-way more clear.

The picture below identifies the typical right-of-way where sidewalks are present. A right-of-way with a rural cross section, the right-of-way will be on the home side of the storm water drainage area (ditch).



The picture identifies the visible public infrastructures; however; the right-of-way also is the location for sanitary and storm sewers; water, gas, and electric distribution systems. It can also be home to television and fiber optic cables.

Property owners adjoining public right-of-ways are responsible for care and safety of sidewalks or drainage areas.

Countdown to the 2010 Census



Vacationers and Snow Birds

Vacationers and snow birds should contact the Police Department to complete a house check form for while you are gone. Our house check form is accessible on the city website www.hiawatha-iowa.com or at the police department during normal business hours, Monday through Friday from 8:00 a.m. to 5:00 p.m. Emergency contact, license plates of vehicles at the residence, and other pertinent information is needed to complete the form. While you are away, officers will check the exterior of the residence to ensure all appears to be in order. This service is utilized by many residents who plan to be out of town for the holidays, on winter vacation, or south for the winter months. The service is free and we encourage you to take advantage of the program.

Water Department Note- Don't forget to call the Water Department to hold your bills, forward your bills, or turn off your water while you are away. Call us at City Hall at 393-5556.

Leaky Toilets and Water Softeners

Over the last few months, we have seen problems with bathroom toilets leaking and water softeners malfunctioning, as well as leaking faucets. All of these leaks will run up your water and sewer bill.

Just a very small leak, 1/32 of an inch, about the size of a pencil lead, running continuously, over three months, will cost you approximately \$123.48.

To help find a bathroom toilet leak, you can call or stop by the Water Department office and ask us for some dye tablets or strips to put in the tank of your bathroom toilet.

This chart will show just how much water can be lost from leaks of different sizes.

All customers are responsible for water lost due to these types of leaks.

A Continuous leak from a hole this size at an average household water pressure of 60 psi would, over a three month period, result in the waste listed below.
