#### Parks Receiving Grant from DNR



#### History of the Hiawatha American Legion

After some "feeler" meetings in late 1997 to see if there was enough interest, the Hiawatha American Legion received its Temporary Charter January 14, 1998 with 15 new members. It received the permanent Charter June 3, 1998. Three Legion members who were responsible for getting it started were: Don McArtor, Dist. Vice Commander of the Fairfax Legion; Dick Krechmeyer, Dist. Chaplin of the Marion Legion and Bob Berridge, past Dist. Commander also of the Marion Post. The first organized meeting was held December 17, 1997. At that meeting Bob Jones was elected Chairman, Dick Harken Secretary/Treasurer and Joe Helle Membership Chairman. Some then went door to door here in Hiawatha and helped "recruit" new members.

June 18, 1998 after receiving its Permanent Charter was the first Official meeting. At that meeting, the following officers were elected: Bob Jones, Commander; Joe Helle, Vice Commander; Rick Farquhar, Finance Officer; Dick Harken, Adjutant; Larry McGuire, Chaplin and Barney Uchytil, Historian. By the end of 1998, the Post had 34 members. Today the total is 125.

The meetings took place in the old Community Center. To get us going financially, a few of the membership went to the businesses here in town and asked for money. We sold flag sets to the community as a fund raiser, took over the Bingo tent at Hog Wild Days in 2002 and started our Avenue of Flags project in 2003. With the income, we were able to start sponsoring the 5th grade essay contest at Hiawatha, Nixon and Gibson and also sponsored Santa now at the Post.

The Post has donated a flag and flagpole to the library, flagpoles to City Hall and black granite plaques in honor of the Armed Services located on the wall leading up to the front entrance of City Hall were donated by the Rock Shop and Legion. We have sponsored teams in the Hiawatha Kids League, sent Kennedy boys to Boys State and the Conley Schweinfus Citizenship Award. We also put flags out in the three cemeteries on Memorial Day and make donations to Veterans programs and others as needed. This year the Womens Auxiliary was able to send a girl to girls state. Our Post hosted National Commander Ron Conley Sr. in November 2003 at the new City Hall and in August 2006 the American Legion World Series was held in Cedar Rapids and the Post sponsored a team from Sumter, South Carolina. We also proudly have a Medal of Honor recipient, Sal Guinta in our membership.

In July of 2010, the Hiawatha American Legion purchased the property at 207 Robins Road for its new home. With the purchase of the hall we now offer Bingo each Wednesday night. Doors open at 5:00 PM and games start at 6:30 PM. We continue to have very good support for the Avenue of Flags from the community and hope that you will continue to do so. #### **Emmons Railroad Cross Repair Complete**

The Emmons Railroad crossing repair and drainage project is now complete. The purpose of the project was to improve drainage and install new pavement approaches after the railroad improved the railroad crossing the previous year. Partnering with the CN Railroad and the IDOT, the work included ditch stabilization, new storm sewer pipe and structures and new pavement and sidewalk replacement. This will help prevent damage to the roadway and railroad tracks during heavy rains. The total cost of the project was approximately \$400,000.00.

In the future after installing new gates and signal lights, the crossing will become a "no whistle" quiet zone. A trail will also be installed on the north side of the street.



#### **Hiawatha Police Department Drug Drop Box**

The Hiawatha Police Department is accepting expired, unused or unwanted medicines 24 hours a day in our drug drop box. The drop box is located inside the front door of the police department. Please enter on the interstate side of the city hall build-



ing to access the police department. The drop box provides a safe disposal method for both prescription and over-the-counter medicines. We do ask that needles, sharps and syringes not be deposited in this container. Drug drop boxes prevent medications from getting into our water supply, youth from accessing and abusing prescription drugs and also prevent accidental and intentional poisonings in the home. We have joined all Linn County Law Enforcement Agencies in making safe disposal a priority within our community.

September 26 marked the National Drug Take-Back Day of which the Hiawatha Police Department participated in. The event encourages all communities to take an active and preventative role in disposing of medications. We have collected and turned in 60 pounds of medication at our police department. Iowa law enforcement agencies collected 8,643 pounds and nationally 742,771 pounds of unwanted medications were properly disposed of during this event.

#### **Hiawatha Police Invited to Fall Festivals**

The Hiawatha Police Department was invited to the annual fall celebrations of two local businesses. Peck's Fall Fun Day took place on October 18. The event draws over 1,000 kids who participate in several activities such as face painting, children's games and hayrack rides. Skogman Realty's Pumpkin Fest was held on October 24 at their Hiawatha office. Pumpkin painting, train rides and a bouncy house are a few of the day's activities geared toward the attendees. A member of the police department answered many questions, handed out temporary tattoos, pencils and provided an opportunity for kids to sit in an actual police car at both events. Additionally, child fingerprinting was offered during Pumpkin Fest. These both are rewarding events that we are excited to be a part of each year.



#### **Smoke Detector Day**

Hiawatha Firefighters had a successful smoke detector event October 16. A total of 16 firefighters split up between four crews and spent the morning installing smoke detectors and replacing smoke batteries. Firefighters go out every fall to visit the homes of people who need assistance changing their smoke detectors. During the visits, firefighters check smoke detectors, replace batteries or detectors as needed. This year, firefighters visited 58 homes, replaced 27 smoke detectors and replaced the batteries or the detectors as needed.

Last year, shortly after firefighters visited the home of Jan Kvach, she experienced a severe kitchen fire that displaced her from her home for several months. She credits the working smoke detectors with helping her escape. When the crew visited Jan this year, she asked that we remind everyone to have a plan; know how to get out of your house and where to go. Most importantly, she emphasized, don't try to fight the fire or delay; get out and call the fire department. We appreciate Jan's support of our safety efforts. As a reminder, smoke detector and carbon monoxide detector batteries should be replaced once a year. Smoke detectors over 10 years old should also be replaced. You should always have an escape plan that you've discussed with your family. If you have a fire, get out and call 9-1-1. Firefighters will help with smoke detectors all year round; if you need non-emergency assistance with your detectors, contact the fire department at 393-4180.



#### **Annual Chili Supper Recap**



The Hiawatha Firefighters held a very successful Chili Supper on Halloween day. The firefighters spent the day before preparing 25 roasters of chili and allowing it

to simmer all night. Members, spouses and friends spent Friday evening making dozen of fresh desserts to share. Dozens of donors provided door prizes, cash donations and supplies. Saturday morning, firefighters started cleaning the station, setting up tables and getting ready for the rush of people. This year, over 900 people came through to support the fire department. This included dozens of kids dressed up in Halloween costumes. The Hiawatha Firefighters offer their thanks to the com-
